NH GUBERNATORIAL CANDIDATES UNKNOWN, DRUG CRISIS MOST IMPORTANT PROBLEM IN NH

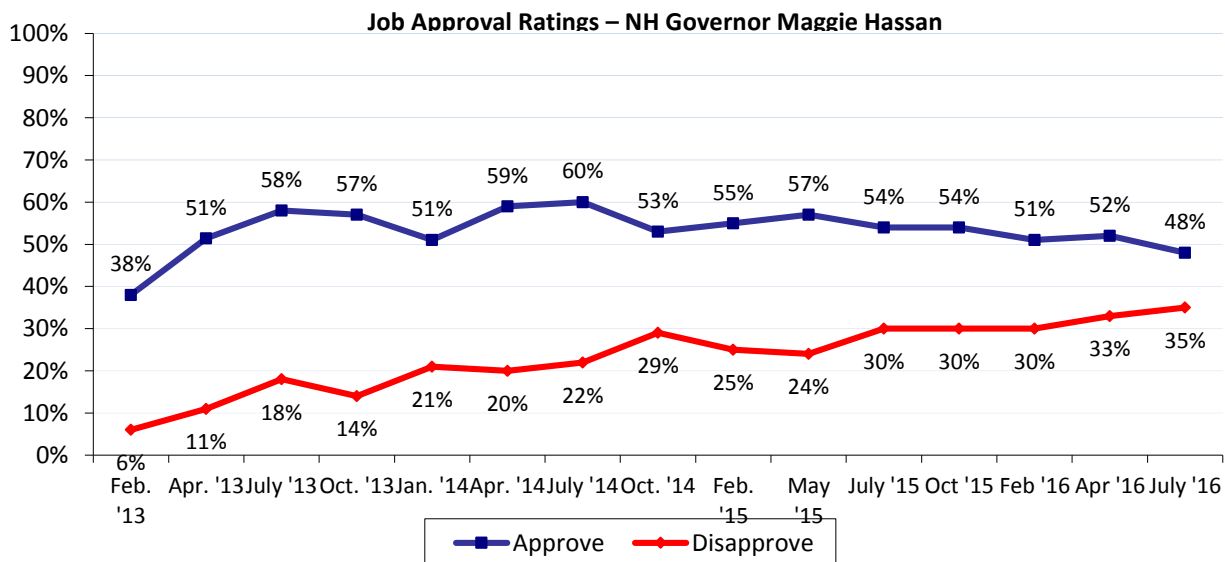

DURHAM, NH – Both Republican and Democratic candidates seeking to replace Governor Maggie Hassan remain unknown to most Granite State voters. Drug abuse remains the biggest problem facing the state. However, a majority of Granite Staters support legalizing marijuana for recreational use in New Hampshire.

These findings are based on the latest **WMUR Granite State Poll**,* conducted by the University of New Hampshire Survey Center. Five hundred and thirty-two (532) randomly selected New Hampshire adults were interviewed by landline and cellular telephone between July 9 and July 18, 2016. The margin of sampling error for the survey is +/- 4.2 percent. Included were four hundred and sixty-nine (469) likely 2016 general election voters (MSE = +/- 4.5%).

Gubernatorial Approval

Outgoing Democratic Governor Maggie Hassan, who is running for U.S. Senate remains popular. However, her job performance rating has declined in recent months. In the latest Granite State Poll, 48% of New Hampshire adults say they approve of the job Hassan is doing as governor, 35% disapprove, and 16% are neutral or don't know enough to say. Democrats (76% approve, 13% disapprove) highly approve of Hassan's job performance, while Independents are divided (39% approve, 47% disapprove) and Republicans disapprove (23% approve, 55% disapprove).

Favorability Ratings – Republican NH Gubernatorial Candidates

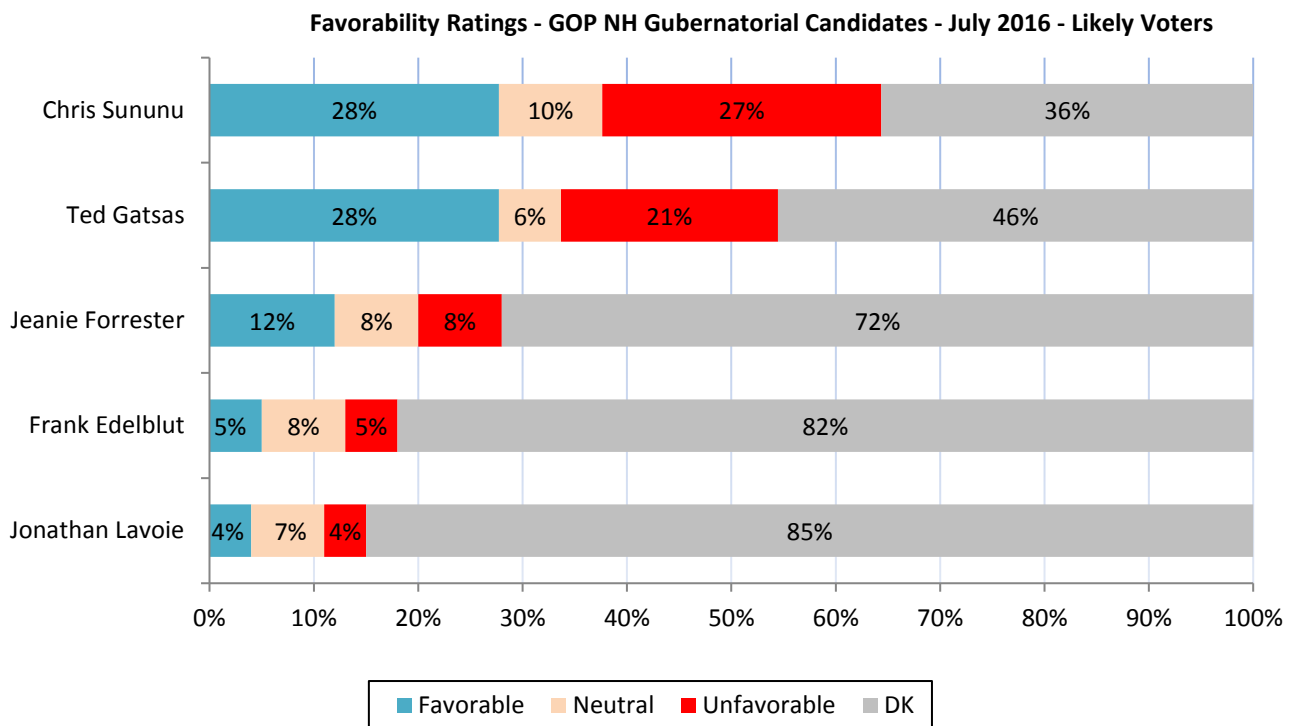
The race to replace Hassan as Governor of New Hampshire is wide open and candidates of both parties are largely unknown to New Hampshire residents. Executive Councilor Chris Sununu of Newfields, the son of former Governor John H. Sununu and the brother of former Senator John E. Sununu, is the best known candidate. Currently 28% of New Hampshire likely voters have a favorable opinion of Sununu, 27% have an unfavorable opinion, 10% are neutral and 36% don't know enough about him to have an opinion (including 37% in the 3rd Executive Council District which he represents). Sununu's net favorability (the percentage having a favorable opinion minus the percentage having an unfavorable opinion) is +1%.

The only other candidate known by a majority of New Hampshire voters is Manchester Mayor Ted Gatsas. In the latest Granite State Poll, 28% of New Hampshire likely voters have a favorable opinion of Gatsas, 21% have an unfavorable opinion, 6% are neutral and 46% don't know enough about him to say. Gatsas' net favorability rating is +7%.

State Senator Jeanie Forrester (R-Meredith) remains unknown to most New Hampshire voters – only 12% have a favorable opinion of Forrester, 8% have an unfavorable opinion, 8% are neutral and 72% don't know enough about her to say. Forrester's net favorability rating is +4%.

Currently 5% of likely voters have a favorable opinion of State Representative Frank Edelblut (R-Wilton), 5% have an unfavorable opinion, 8% are neutral and 82% don't know enough about him to say. Edelblut's net favorability rating is +0%.

Jonathan Lavoie of Hollis is also unknown to New Hampshire likely voters – only 4% have a favorable opinion of Lavoie, 4% have an unfavorable opinion, 7% are neutral and 85% don't know enough about him to say. Lavoie's net favorability rating is +0%.



Favorability Ratings – Democratic NH Gubernatorial Candidates

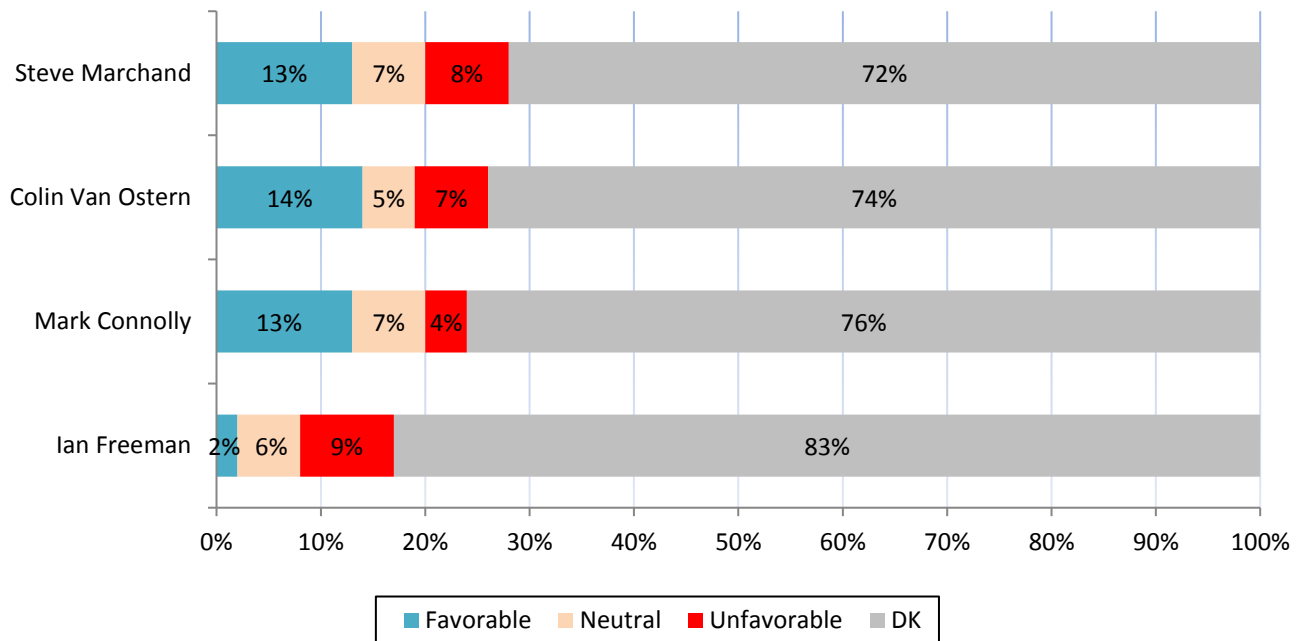
The Democratic candidates seeking to replace Hassan are unknown to the large majority of New Hampshire voters. Currently 13% of likely voters have a favorable opinion of former Portsmouth Mayor Steve Marchand, 8% have an unfavorable opinion, 7% are neutral and 72% don't know enough about him to say. Marchand's net favorability rating is +5%.

Only 14% of likely voters have a favorable opinion of Executive Councilor Colin Van Ostern (D-Concord), 7% have an unfavorable opinion, 5% are neutral and 74% don't know enough about them to say. Van Ostern's net favorability is +7%.

And only 13% have a favorable opinion of Former NH Bureau of Securities Director Mark Connolly (D-New Castle), 4% have an unfavorable opinion, 7% are neutral and 76% don't know enough about them to say. Connolly's net favorability is +9%.

Ian Freeman of Keene, is even less well known as only 2% have a favorable opinion of him, 9% have an unfavorable opinion, 6% are neutral and 83% don't know enough about him to say. Freeman's net favorability is -7%.

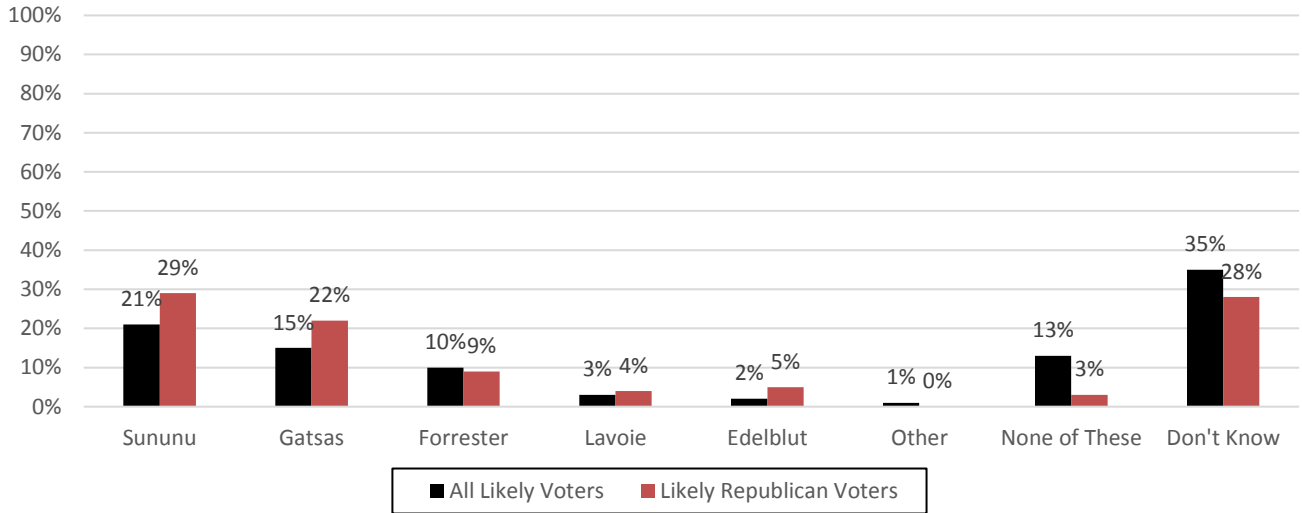
Favorability Ratings - DEM NH Gubernatorial Candidates - July 2016 - Likely Voters



Preference of NH Gubernatorial Candidates

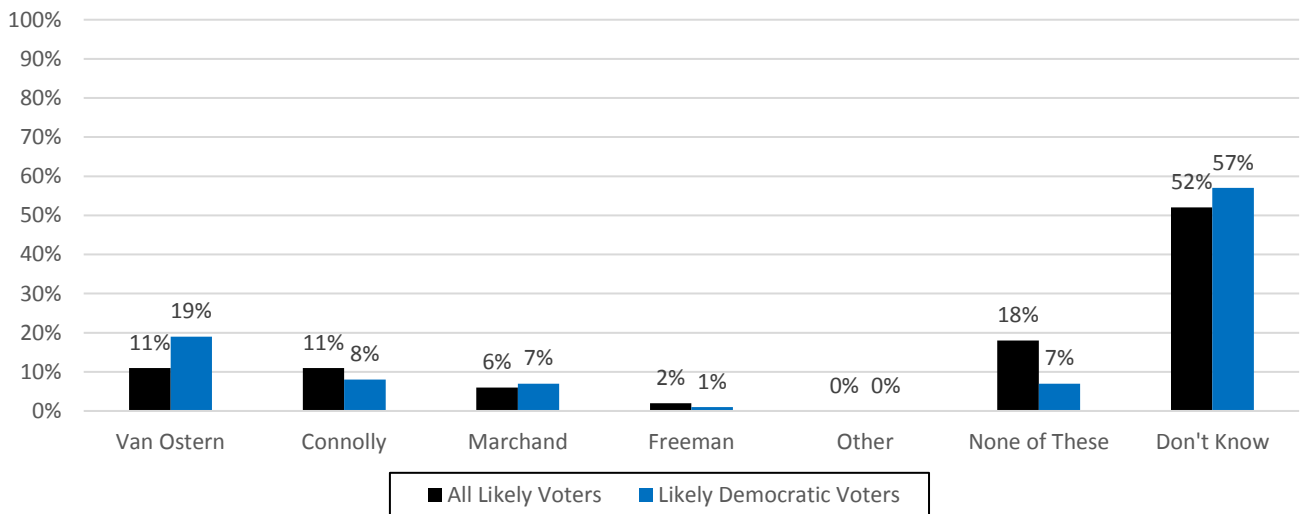
Likely November voters were asked which of the Republican gubernatorial candidates they would be most likely to vote for, regardless of their own partisanship. Overall, 21% named Chris Sununu, 15% chose Ted Gatsas, 10% chose Jeanie Forrester, 3% chose Jonathan Lavoie, 2% chose Frank Edelblut, 1% chose someone else, 13% chose none of them, and 35% were not sure. Among Republican likely voters 29% chose Sununu, 22% chose Gatsas, 9% chose Forrester, 5% chose Edelblut, 4% chose Lavoie, and 28% are undecided.

GOP Gubernatorial Candidate Most Likely To Vote For



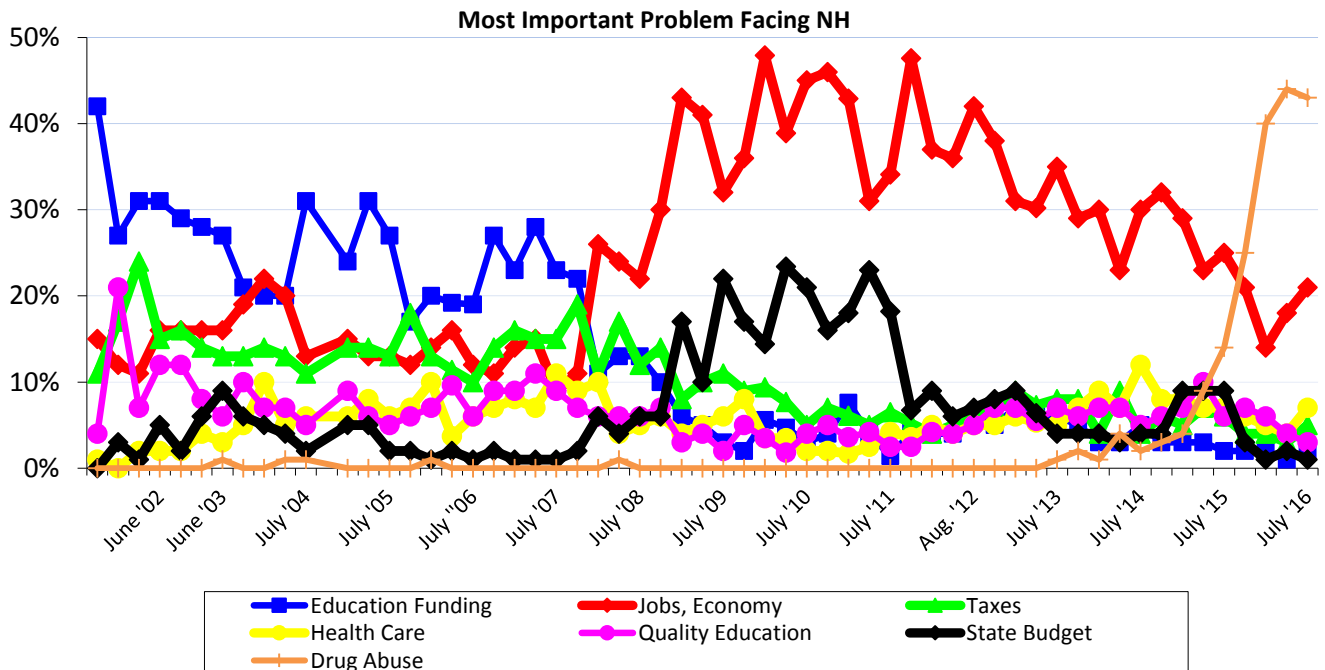
When likely voters were asked which of the Democratic gubernatorial candidates they would be most likely to vote for 11% chose Colin Van Ostern, 11% chose Mark Connolly, 6% chose Steve Marchand, 2% chose Ian Freeman, 18% chose none of them, and 52% were not sure. Among Democratic likely voters 19% chose Van Ostern, 8% chose Connolly, 7% chose Marchand, 1% chose Freeman, and 57% are undecided.

Most Important Problem Facing New Hampshire

Granite Staters remain very concerned with the drug crisis facing the state -- currently, 43% of New Hampshire adults cite drug abuse as the most important problem facing the state, followed by jobs and the economy (21%), health care (7%), taxes (5%), education (5%), and the state budget (1%).

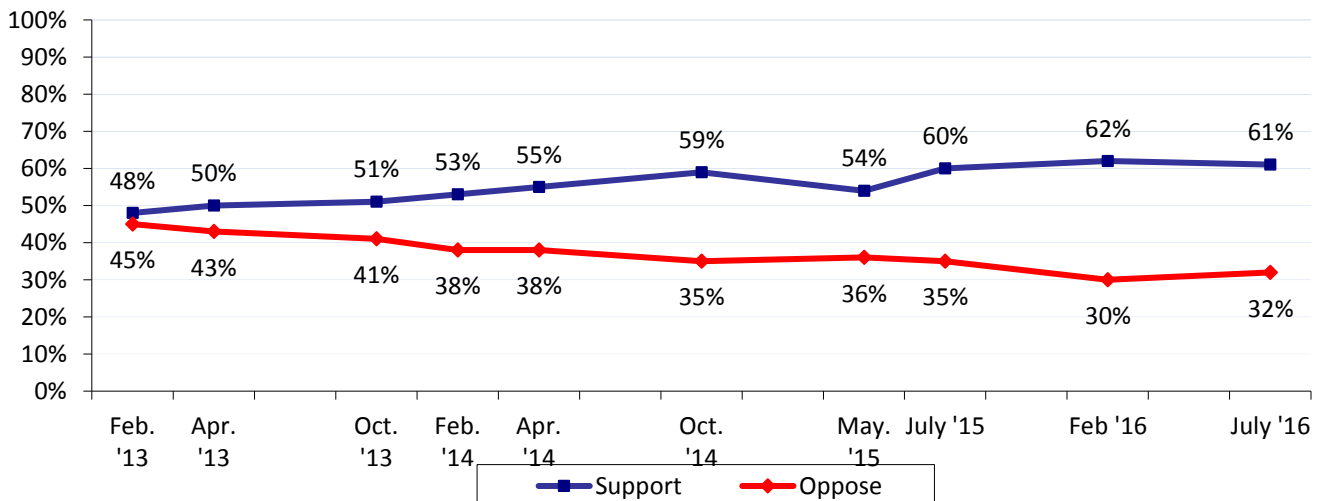


Recreational Marijuana Legalization

Despite the concerns about drug abuse, New Hampshire legalized marijuana for medical purposes in 2013, but bills to legalize recreational marijuana for recreational use have not passed the legislature. However, a majority of Granite Staters support legalizing recreational marijuana in New Hampshire and have for several years. Currently, 61% support legalizing marijuana for recreational use (39% strongly and 22% somewhat), 32% oppose (22% strongly and 10% somewhat) and 7% are neutral or unsure.

Support for recreational marijuana legalization is strongest among liberals (79% support), those who never attend church (79%), younger adults (77%), and Democrats (73%). Opposition is strongest among regular churchgoers (51% oppose), conservatives (51%), and older residents (48%).

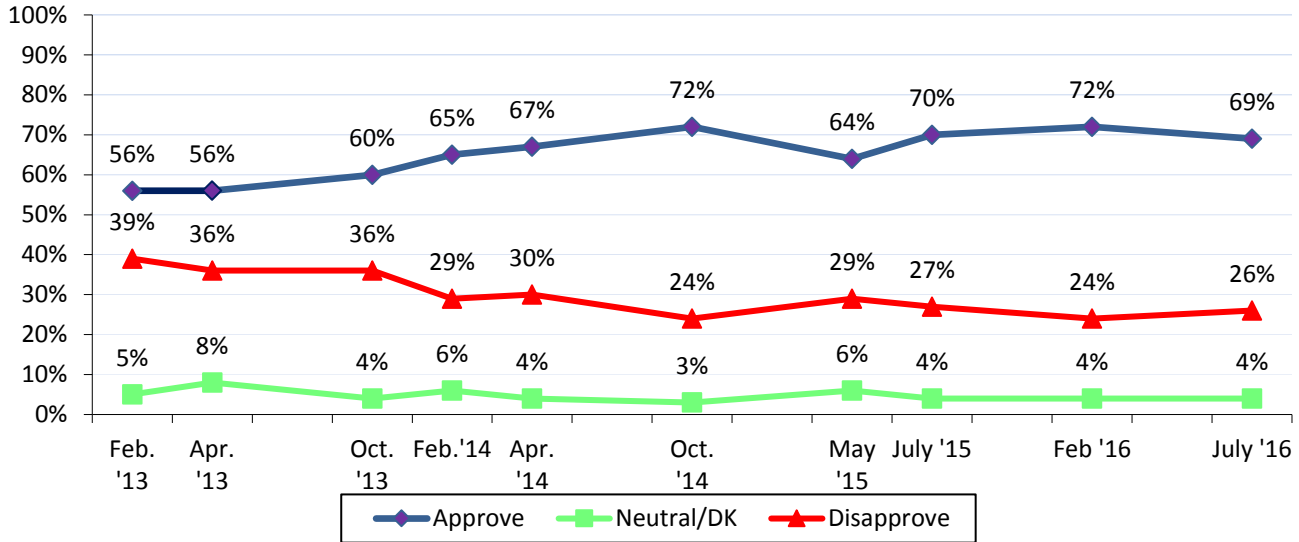
Support/Oppose Legalizing Marijuana For Recreational Use



Approve of Marijuana Sold At Licensed Outlets?

If marijuana were legalized in the Granite State, a majority of New Hampshire residents (69%) approve of selling it at licensed retail outlets and taxing it similar to how alcohol is sold (46% strongly and 23% somewhat); only 26% disapprove of this idea (20% strongly and 6% somewhat), 2% are neutral, and 2% are unsure.

Approve of Marijuana Being Sold at Licensed Outlets and Taxed at Liquor Levels

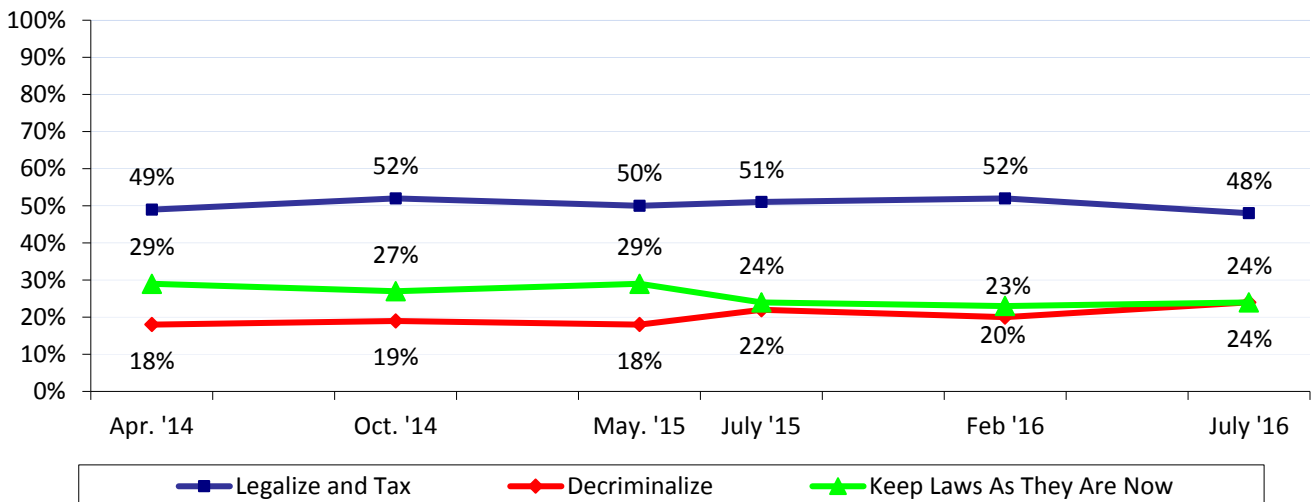


Preference for Marijuana Laws

When asked what they would prefer the state legislature do about marijuana laws, 48% want marijuana legalized and taxed like alcohol, 24% want it decriminalized, 24% want to keep marijuana laws as they are now and 3% don't know or are unsure. This measure has remained steady over the past two years.

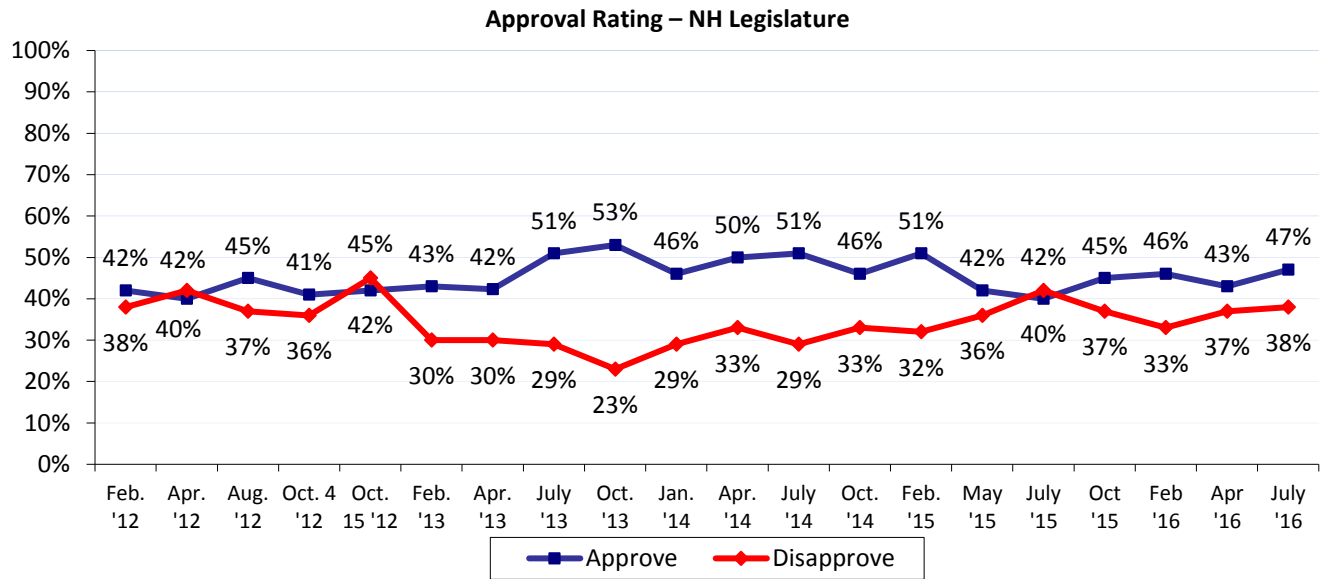
Majorities of Democrats (56%) and Independents (51%) prefer legalizing and taxing marijuana, while Republicans are more divided on the issue as 40% prefer legalization and 32% prefer keeping laws the way they are now.

Preference for Marijuana Laws in NH



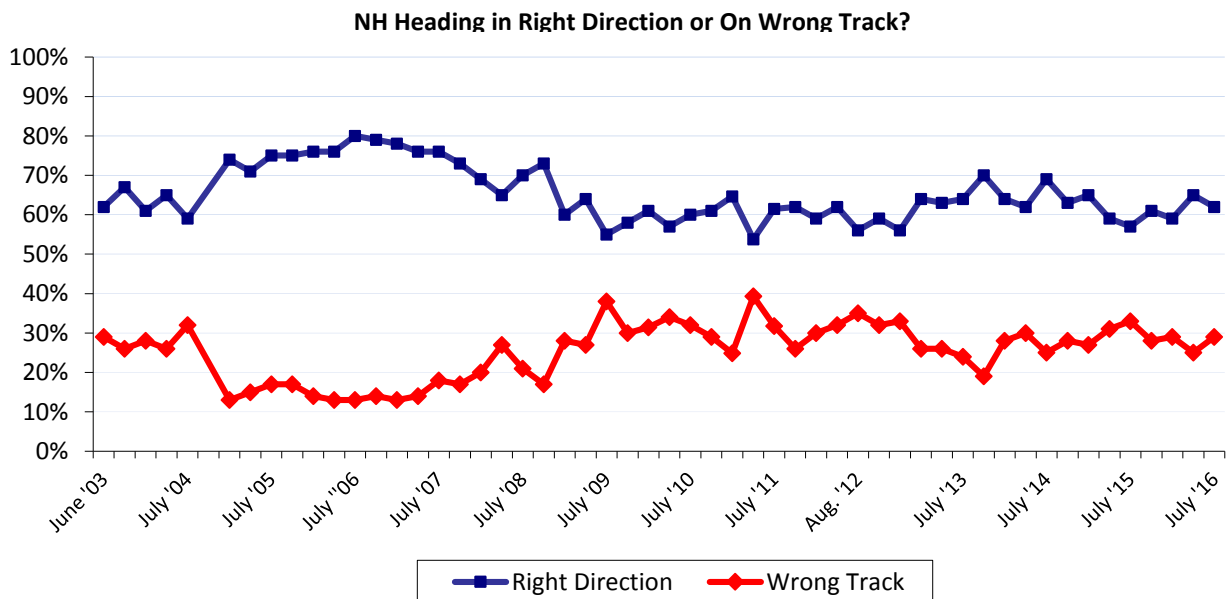
Approval of New Hampshire Legislature

New Hampshire residents are divided on how the state legislature is performing its job. Currently, 47% of New Hampshire adults approve of how the State Legislature is doing its job, 38% disapprove, and 16% are neutral or don't know enough to say. Slight majorities of Republicans (46% approve, 34% disapprove), Independents (52% approve, 34% disapprove), and Democrats (45% approve, 42% disapprove) approve of the state legislature.



Right Direction or Wrong Track?

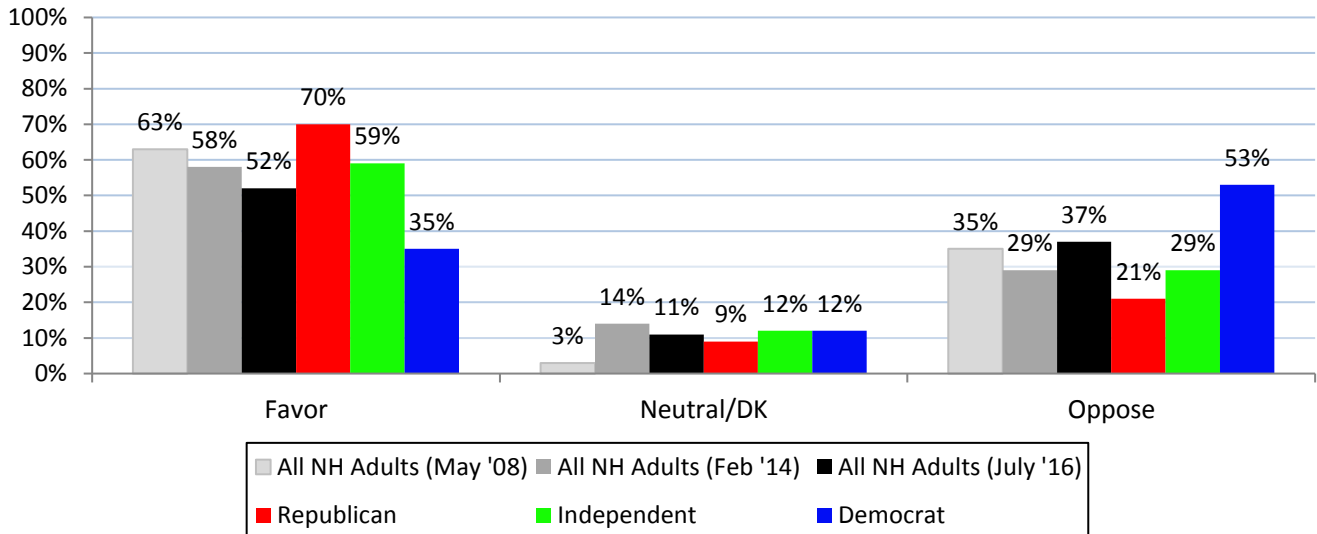
New Hampshire residents believe the state, as a whole, is headed in the right direction. Currently, 62% of New Hampshire adults feel the state is heading in the right direction, 29% think the state is seriously off on the wrong track, and 9% are unsure. Majorities of Democrats (70%), Independents (62%), and Republicans (54%) say the state is headed in the right direction.



Death Penalty

Support for the death penalty has been declining in recent years. A slim majority (52%) of New Hampshire residents are in favor of the death penalty for a person convicted of murder, 37% oppose and 11% are either neutral or don't know enough to say. Majorities of Republicans (70%) and Independents (59%) are in favor of the death penalty while Democrats are more likely to oppose the death penalty (53%).

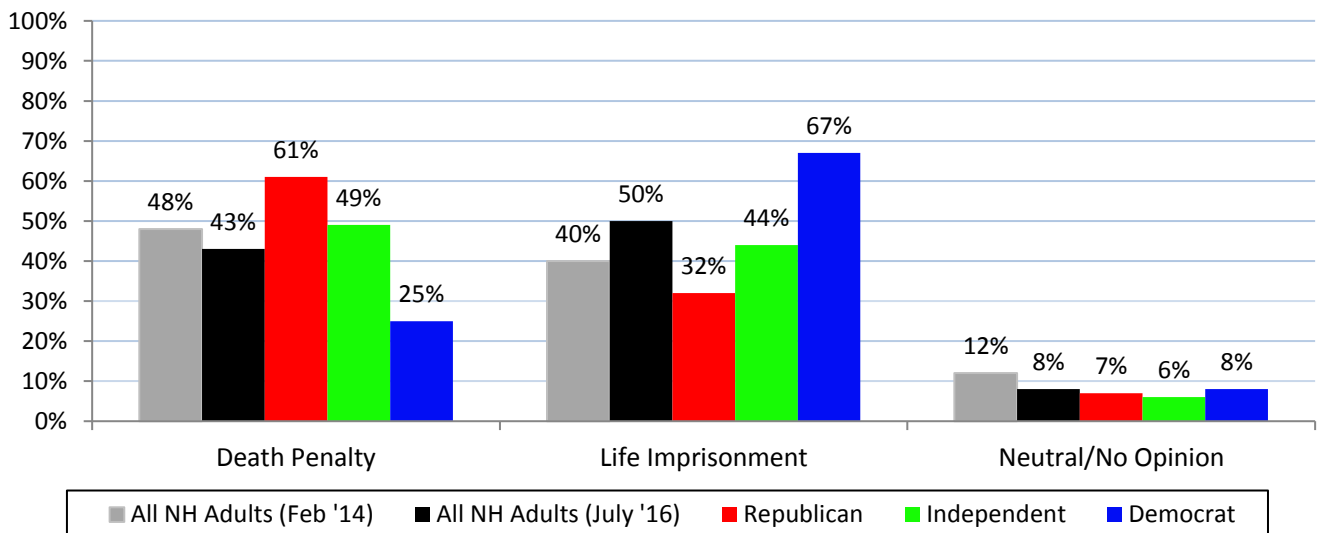
Favor/Oppose Of Death Penalty



Death Penalty or Life Imprisonment For Convicted Murderers?

However, when given the choice between the death penalty or life imprisonment for someone convicted of murder, Granite Staters are divided – 50% prefer life imprisonment, 43% prefer death penalty, and 8% are either neutral or have no opinion. This marks a change since February 2014 when 48% preferred the death penalty and 40% favored life imprisonment. There is also a partisan divide on this issue as 61% of Republicans and 49% of Independents favor the death penalty while two thirds of Democrats (67%) favor life imprisonment.

Granite State Poll Methodology

These findings are based on the latest WMUR Granite State Poll, conducted by the University of New Hampshire Survey Center and funded by WMUR-TV, Manchester, NH. Five hundred and thirty-two (532) randomly selected New Hampshire adults were interviewed in English by landline and cellular telephone between July 9 and July 18, 2016. If a household included more than one adult, the adult who had the most recent birthday was selected to be interviewed.

The margin of sampling error is +/- 4.2 percent for the entire sample. Included were four hundred sixty-nine (469) likely 2016 general election voters (MSE +/- 4.5%). These MSE's have not been adjusted for design effect. The design effect for the survey is 1.1%.

The random sample used in the WMUR Granite State Poll was purchased from Marketing Systems Group (MSG), Horsham, PA. MSG screens each selected telephone number to eliminate non-working numbers, disconnected numbers, and business numbers to improve the efficiency of the sample, reducing the amount of time interviewers spend calling non-usable numbers.

The data have been weighted to adjust for numbers of adults and telephone lines within households. Additionally, data were weighted by respondent sex, age, and region of the state to targets from the most recent American Community Survey (ACS) conducted by the U.S. Census Bureau. In addition to potential sampling error, all surveys have other potential sources of non-sampling error including question order effects, question wording effects, and non-response. Due to rounding, percentages may not sum to 100%. The number of respondents in each demographic below may not equal the number reported in cross-tabulation tables as some respondents choose not to answer some questions.
